**ORDER**

Sub: **Lock Down 4.0 Implementation Orders for the period May 18<sup>th</sup> to May 31<sup>st</sup>, 2020.**

The lockdown imposed in the entire country has been further extended up to May 31<sup>st</sup>, 2020 vide Order No. 40-3/2020-DM-I(A) dated May 17<sup>th</sup>, 2020 issued by Ministry of Home Affairs, Government of India. Accordingly, the following Implementation Guidelines are issued in respect of the Lockdown 4.0 in the State of Rajasthan for the period **May 18<sup>th</sup> to May 31<sup>st</sup>, 2020**, in accordance with the Guidelines issued by Ministry of Home Affairs dated May 17<sup>th</sup>, 2020.

These Guidelines are based on the twin principles of safety and precautions against community spread of COVID-19 as well as securing livelihood through resumption of economic activities in the State. They are in supersession of all previous orders in this regard, unless specifically mentioned.

**A. RESTRICTIONS:**

The **following restrictions shall continue to apply in the entire State until 31<sup>st</sup> May, 2020**, irrespective of the Zonal classification, i.e. Red, Orange or Green :

**(1) Under Section 144 CrPC :**

- (a) Restriction on the movement and gathering of 5 or more persons at a public place, unless specifically, and up to the extent, provided for in these guidelines, eg. as in A. (3) vi. and vii.
- (b) The movement of individuals, for all non-essential activities, shall remain strictly prohibited between 7 pm to 7 am.

This shall not apply to the following:

- (1) Police / District administration / Government officials on active field duty.
- (2) Doctors and other medical / para-medical staff (government / private) on shift / emergency duty.
- (3) Staff of IT and ITeS companies (night travel pass to be obtained from district administration / police)



- (4) For medical or other emergency.
- (5) Owner / Staff of chemist shops – (with night travel pass)
- (6) Movement of trucks / carrier vehicles carrying goods / construction or any other material or returning back empty.

- (c) All work places (Shops / offices / factories etc.) shall close latest by 6 pm or such earlier time to enable the staff and others to reach back home by 7 pm, unless special permission is obtained from the district administration in this regard.

However, this will not be applicable on the following:

- (1) Factories with production of continuous nature
- (2) Factories having night shifts
- (3) Construction activities (during acute summer period)

**Condition :** They will manage the shifts in such way that there is no movement of labour / staff on roads during the period 7 PM to 7 AM and that the shifts are spaced in the manner prescribed.

- (4) IT and ITeS companies
- (5) Chemist shops

**(2) Prohibited Activities: The following activities will continue to remain prohibited across the State:**

- i. All domestic and international air travel of passengers, except for domestic medical services, domestic air ambulance, and for security purposes or purposes as permitted by MHA, GOI.
- ii. Metro rail services.
- iii. Schools, colleges, educational / training / coaching institutions etc. will remain closed. Online / distance learning shall be encouraged.
- iv. Hotels and other hospitality services, except those meant for housing health / police / Government officials / healthcare workers, stranded persons including tourists, and for quarantine facilities; also canteens at bus depots, railway stations and airports.
- v. All cinema halls, shopping malls, gymnasiums, swimming pools, entertainment parks, theatres, bars, auditoriums, assembly halls and similar places.
- vi. All social/ political / sports / entertainment / academic / cultural/ religious functions / other gatherings and large congregations.
- vii. All religious places / places of worship shall be closed for public. Religious congregations are strictly prohibited.
- viii. Sale of *paan*, *gutka*, tobacco etc. shall be prohibited

- (3) Restricted Activities: The following shall be permitted, except in Containment Zones, with restrictions,:**
- i. Sports complexes, stadia, golf course, polo ground etc. will be permitted to open; however, clubhouses and similar facilities shall not be opened and spectators will not be allowed.
  - ii. Restaurants, Eateries, Mithai shops etc. – For take away and home delivery only; no customer will be permitted inside the premises.
  - iii. All **shops** can be open **but with the following restrictions:**
    - (1) No sale shall be made by the shopkeeper to any customer who is not wearing a mask. Any violation shall result in fine, closing of shop or legal action.
    - (2) Shops will ensure that not more than 2 customers, in a small shop, and not more than 5 customers in a large shop, shall be permitted within at any one point of time with social distancing (six feet distance). Others are to wait their turn in queue outside, with social distancing ensured.
    - (3) It does not include shops in malls.
  - iv. Barber shops, salons, beauty parlours etc. with complete safety precautions, disinfection and sanitization after service of each customer.
  - v. Persons above 65 years of age, persons with co-morbidities, pregnant women and children below the age of 10 years shall stay at home, except for essential and health purposes.
  - vi. Marriages related gatherings shall give prior permission from SDM, ensure social distancing, and the maximum number of guests allowed shall not be more than 50. Violation of any of these is an offence and punishable with heavy fine.
  - vii. Funerals / last rites related gatherings shall ensure social distancing, and the maximum number of persons allowed shall not be more than 20.



## **B. COMMON PRESCRIPTIONS:**

The following **standard precautions and restrictions** shall remain **applicable** for all areas and all districts:

### **PUBLIC SPACES**

1. Wearing of face cover is compulsory in all public and work places. Not wearing mask shall be punishable with fine.
2. Spitting in public & work places shall be punishable with fine.
3. Social distancing (minimum 6 feet – “*do gaz ki doori*”) shall be followed by all persons in public places and transport. Not observing shall be punishable with fine.
4. Consumption of liquor, *paan*, *gutka*, tobacco etc. in public place is strictly prohibited.

### **Additional for WORK PLACES** (Offices, Establishments, Factories etc.)

5. As far as possible, the practice of work from home should be followed.
6. All persons in charge of work places shall ensure social distancing, through adequate distance between workers, adequate gaps between shifts, staggering the lunch breaks of staff etc.
7. Staggering of work / business hours shall be followed in offices, work places, shops, markets and industrial and commercial establishments.
8. Provision for thermal scanning, hand wash and sanitizer will be made at all entry and exit points and common areas.
9. Frequent sanitization of entire workplace, common facilities and all points which come into human contact eg. door handles etc. shall be ensured, including between shifts.
10. All employers shall encourage and motivate their employees to install, and use, on their mobile phones, *Arogya Setu* for common and personal safety.
11. Intensive communication and training on good hygiene practices shall be taken up.

**The District Magistrate shall enforce the Restrictions and Common Prescriptions, as stated above, through fines and penal action as prescribed in the Disaster Management Act, 2005 / The Rajasthan Epidemic Diseases Ordinance, 2020.**



## C. PERMITTED ACTIVITIES:

### Common for all Zones:

1. All such offices, shops, establishments, factories, services and other activities etc. that are **not** in the "**prohibited activities**" category **can open / operate**. Similarly, all such units etc. that are in the "**restricted activities**" category can open with the restrictions prescribed. There is **no need** for any separate **permission** (unless specifically provided for), subject to the following **conditions**:
  - (1) Such units etc. shall ensure that they observe the basic **precautionary measures specified in part B**.
  - (2) The District Magistrate, through the Departments / Agencies concerned, shall ensure that these standards / precautions are observed by all these units.
  - (3) **Any unit found not observing the conditions shall be shut down and penal action taken.**
  - (4) **Strict legal action** will be taken against **any unit that is in the prohibited category** and found to be open, for violating the orders issued under lockdown.
  - (5) For any unit that is not clear as to whether it is in the "prohibited" category or not, clarification may be sought from the District Administration.

## D. CLASSIFICATION OF DISTRICTS IN "ZONES":

1. Areas in the State are classified in three zones based on risk profiling, namely **RED ZONE, ORANGE ZONE** and **GREEN ZONE**.
2. The present classification of the areas in the State in the 3 Zones is given in **Annexure-1**. This classification can be revised by the State Government when risk profile changes for any particular area(s).
3. **CONTAINMENT ZONES**

Strict protocol will be observed in the Containment Zones within the Red Zone and Orange Zone Districts as stated in the MoHFW guidelines and only essential activities shall be allowed. There shall be strict perimeter control to ensure that there is no movement of population in or out of these zones except for medical emergencies and for maintaining supply of essential goods and services.

No relaxations of any kind permitted in these guidelines are applicable within the containment areas of hotspots and clusters / curfew areas. Similarly, any subsequent relaxations accorded during the Lockdown period also shall not be applicable unless the same is specifically stated in the order issued.

**ZONE WISE restricted activities are as follows:**

- I. **RED ZONE** (other than Containment Zone / curfew area)  
The following activities will function with the restrictions as stated below:
- 1. Government OFFICES**  
Departments / Offices dealing with important and essential work – full strength; Others with full strength of officers and 50% staff and remaining staff on work-from-home basis.
  - 2. COMMERCIAL, INDUSTRIAL and SERVICE ESTABLISHMENTS**  
Staff as per requirement; however, work-from-home to be encouraged.
  - 3. OTHER PRIVATE OFFICES**  
50% staff and remaining staff on work-from-home basis.
  - 4. Public / Community PARKS shall remain closed**
  - 5. TRANSPORT**  
No commercial passenger transport (buses, taxis, auto rickshaws, cycle rickshaws etc.) unless specifically permitted.
- II. **ORANGE ZONE** (Outside Containment Zone / curfew area) :  
All such activities as permitted for Red Zone shall also be permitted for Orange Zone. In addition, the following is permitted:
- 1. Offices**  
All Government offices and private offices - with up to two-thirds staff; rest on work-from-basis.



## 2. Public / Community Parks

From 7 am to 6.30 PM only. Social distancing (six feet distance / *do gaz ki doori*) shall be strictly maintained and observance of all restrictions including no gathering of 5 or more persons at any one place.

## 3. Transport

The following commercial passenger vehicles will be permitted:

- (a) Taxis and cab aggregators (OLA, Uber etc.) – Driver plus maximum 2 passengers.
- (b) Auto rickshaw / cycle rickshaw – Driver plus one passenger.
- (c) Inter-city bus service as per route approved by Home Department
- (d) City Buses will not be permitted.

## III. GREEN ZONE :

**ALL activities are permitted** in Green Zones **except those** activities that are **prohibited / restricted** in **Part A** of this order.

**ALL Common Prescriptions** stated in **Part B** shall be **mandatory** for all persons and those in charge of work places.

## E. MOVEMENT OF PEOPLE / TRANSPORT / PASSES

- (i) Standard Operating Procedures (SOPs) for movement of persons, as mentioned in Annexure-1 of MHA Guidelines dated May 17<sup>th</sup>, 2020 shall continue to operate.
- (ii) Inter-State movement of passenger vehicles (including buses / taxis) with mutual consent of the State(s) / UT(s) involved.
- (iii) Inter-State and within State movement of any **truck or other goods / carrier vehicle**, whether with goods, livestock, mining or construction material etc. or empty, shall not be hindered.
- (iv) Inter-State and within State movement of medical professionals, nurses and para-medical staff, sanitation personnel and ambulances shall be permitted without any hindrance.

- (v) Transportation of labour within the State from one district (any zone) to another (any zone) for work in industry or construction activity is permitted.
- (vi) Within State movement of buses is permitted on routes allowed by Home Department.
- (vii) **City Bus service** is permitted **Green Zones**.
- (viii) All other commercial passenger transport vehicles – taxi, cab aggregators (OLA/ Uber etc.) auto rickshaw, cycle rickshaw – are also permitted to ply, subject to any zone-wise restriction.
- (ix) **The passengers** travelling in any vehicle (personal or commercial) **shall not exceed the permitted seating capacity** as approved by the RTO/DTO initially.
- (x) **No Pass shall be required for movement of persons or vehicles within the State**, unless specifically stated because of zonal restrictions. However, such movement will be subject to the following **conditions:**
  - (1) The movement of individuals / vehicles is **only for** permitted activities under these guidelines / for emergency.
  - (2) Strict legal action shall be taken against any person who violates the conditions of the lockdown, including impounding of the vehicle.


**(xi) Pass / NOC for travel outside or into State**

This will be in accordance with the procedure stated in NOC issued vide order dated May 11<sup>th</sup>, 2020 and Addendum dated 13-05-2020.

**Note:** No pass will be required for persons travelling outside the State by scheduled train or bus service {as per E (ii) above for buses}.

**F. IMPLEMENTATION MACHINERY**


The implementation machinery shall be the same as per the Order of even number dated March 26<sup>th</sup>, 2020.
